- * Each business should be prepared to provide candy for 90 minutes (approx 1500 trick or treaters)
- * Vehicles must arrive between **5:00- 5:30pm** (no cars will be allowed to enter the trunk or treat line after 5:30)
- * Trunks/Vehicles must be decorated.
- * All candy must be unopened and individually wrapped.
- * Vehicles must be used for trunk or treat. Decorations, tables, chairs must remain within reserved space.
- * There is NO FEE to participate.
- * All businesses must pre-register.
- * LIMITED # SPACES ARE AVAILABLE! Registrations are accepted on a first come first serve basis.

Please Note: The event has grown tremendously over the years and in the interest of safety, we must ask that **NO** crafts, games or additional activities be offered during the trunk or treat portion of the event. Businesses ARE allowed and encouraged to hand out other promotional material in addition to candy, provided it does not interfere with or stop the trunk or treat line.
